TERMS AND CONDITIONS

- 1. Information on how to enter and prizes form part of these Conditions of Entry. Participation in this competition is deemed acceptance of these Terms and Conditions.
- 2. Entry is open to all ordinary Australian persons who reside in Australia ("Eligible Entrants"). Eligible Entrants under 18 years of age must have parental/guardian approval to enter and further, the parent/guardian of the Eligible Entrants must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this competition.
- 3. Employees (and their immediate families) of the Promoter, participating outlets and the agencies associated with this promotion are ineligible to enter this competition. Immediate family means any of the following: spouse, ex-spouse child or step-child (whether natural or by adoption), parent, step-parent.

 - B. meet the relevant criteria set out in the "2024 Toyota Good for Footy AFL National Volunteer Awards" guidelines found via <u>https://play.afl/afl-national-volunteer-awards</u>. Award categories are:
 - (a) Toyota AFL Community Volunteer of the Year;
 - (b) Toyota AFL Young Leader of the Year;
 - (c) Toyota AFL Community Club of the Year;
 - (d) NAB AFL Auskick Volunteer of the Year;
 - (e) AFL Disability Inclusion Ambassador of the Year;
 - (f) AFL Diversity National Ambassador of the Year;
 - (g) AFL National Community Umpiring Service Award;
 - (h) AFL National Community Football Media Award;
 - (i) AFL National Community Football Photography Award;
 - (j) AFL Women Community Coach of the Year;
 - (k) AFL Men Community Coach of the Year;
 - (I) AFL School Teacher of the Year; and
 - (m) AFL School of the Year.
 - C. N.B.: For "Women" and "Men" award categories listed in clause 4B, an individual that does not identify by gender as either 'woman' or 'man' can be nominated in either the 'women' or 'men' category (but not both). This category decision would need to be endorsed by the person being nominated.
- 5. The Promoter reserves the right, at any time, to invalidate any entries which it reasonably suspects have been submitted: (a) using false, incorrect, fraudulent or misleading information,

including but not limited to personal details and contact information; (b) through the use of multiple identities, email addresses or accounts; and/or (c) in any way in contravention of these Terms and Conditions.

- 6. Incomplete, illegible or incorrect entries, or those which contain offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, will be deemed invalid.
- 7. If there is a dispute as to the identity of an Eligible Entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the Eligible Entrant.
- 8. The Promoter reserves the right, at any time during, or after the closing date of the competition, to verify the validity of entries and Eligible Entrants (including an Eligible Entrant's identity and place of residence) and to disqualify any Eligible Entrant associated with an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 9. Entries are deemed to be received at the time of receipt into the Promoter's competition database and NOT at the time of completion of the entry. Any cost associated with entering the competition is the Eligible Entrant's responsibility.
- 10. Each State and Territory Controlling Body (e.g. AFL Queensland) will first select one winner for each award category for its State or Territory. The State and Territory winners will be notified by the State or Territory to the Promoter via phone and email by no later than Monday, 29 July 2024. The Promoter will then select the National winners for each award category from the pool of State and Territory winners. The judging for the National winners will take place at AFL House, 140 Harbour Esplanade, 3008 on Monday, 5 August 2024. The National winners will be notified via phone and email by no later than Monday, 12 August 2024 to organise the claiming of their prize(s). The Promoter's decision is final and no correspondence will be entered into. The National winners' names will be published on AFL social media pages/AFL website by no later than Saturday, 28 September 2024.
- 11. This is a contest of skill, judged on criteria set by the Promoter. Chance will not play a role in determining the competition winner.
- 12. Each State and Territory winner for each of the award categories (as set out in clause 4(B)) will win one (1) prize consisting of a \$200 e-gift (prepaid Mastercard). The e-gift will be redeemable for use via a "Smartphone" anywhere in Australia where Mastercard is accepted. A total of ninety-one (91) e-gifts will be awarded to the ninety-one (91) State and Territory winners. There is a limit of one (1) prize per State and Territory winner for each category set out in 4(B).
- 13. The National winner for each of the award categories set out in 4(B) will win one (1) prize consisting of each of the following:
 - a) Return economy flights via Virgin Australia from their nearest capital city to Melbourne on Thursday, 26 September 2024 and return on Sunday, 29 September 2024. For avoidance of doubt, if the National Winner resides in Victoria (Mildura excepted), flights will not be included;
 - b) Three (3) nights' accommodation in Melbourne: Check-in Thursday, 26 September 2024 and Check-out Sunday, 29 September 2024;
 - c) 'Welcome to Melbourne' function to be held in Melbourne on the evening of Thursday, 26 September 2024 (including meal and limited drinks);

- d) AFL Grand Final parade attendance; and
- e) Reserved seat ticket to the 2024 Toyota AFL Grand Final.
- 14. Total value for each prize is variable based on the location of each National winner. Each prize for the National winners is valued at approximately \$2,3500.00. Thirteen prizes will be awarded in total. There is a limit of one (1) prize per National winner for each category set out in 4(B).
- 15. In addition to the above prize, the National winner of the 2024 Toyota AFL Community Volunteer of the Year and Toyota AFL Young Leader of the Year award categories will also win a new 2024 Corolla Hatch SX Hybrid. Driveaway value of approximately \$40,289.00 (including GST). For the avoidance of doubt, these prizes are not applicable to any of the other award categories outlined in 4(B).
- 16. The total prize pool for all winners under this promotion (as set out in 12 and 13) is valued at approximately \$132,519.00 (including GST).
- 17. If for any reason a winner does not take the prize or any part of the prize at the time stipulated by the Promoter, then the prize or that part of the prize cannot be transferred, exchanged or redeemed for cash.
